2. MINUTES OF THE LAST PARISH COUNCIL MEETING HELD ON 30 OCTOBER 2014

3. MATTERS ARISING FROM THE MINUTES

3.1 Highway Matters – Mrs Patmore will once again report the poor condition of the Brandsby to Crayke road. There has been some work in Stearsby. There is a water leak at the end of The Avenue. The Clerk will report this leak to Yorkshire Water.

The moving of the Brandsby sign is the responsibility of the PC and Mrs Patmore is going to ask NYCC Highways for more information on how to proceed. The Clerk wished to know what the cost of this work would be.

3.2 Planning matters – The Chairman expressed his disappointment and anger at the shed which has been built in the field at 2 Woodside, Brandsby. At the outset the PC was not agreeable to some aspects of the plans and HDC Planning Department has taken no notice of either the PC or the private individuals who made comments.

3.3 Cholmeley Hall – Graham Kay, the member of public present, reported that two new members had been recruited onto the Committee. This made things a little easier and the committee were now more optimistic with renewed enthusiasm. The finances are healthy and a new oven and microwave have been purchased. In the future it was hoped that a better heating system could be installed.

3.4 Advertising signs – The Clerk emailed NYCC re the “laying of hedge” sign on the verge approaching Brandsby on the Stillington road. No response has been received. Mrs Patmore will ask NYCC to remove this sign.

She asked whether we have a “First Responder” in Brandsby. We have not but the chairman will put a notice in the church magazine to see if anyone is interested in becoming one. A “trained” first aider would be appropriate.

6.3 Grant money available – The Clerk received an email from Mrs Cookman re the availability of “a pot of money” to spend on any projects that will make a difference to people’s lives. Mr Graham Kay, the member of public present, and chairman of the Cholmeley Hall Committee will liaise with Mrs Cookman with the possibility of making an application for a grant.

7.1 Council Elections – The Clerk gave out the nominations packs to the present councillors who wish to stand in the May Election. The Clerk asked that when the nominees completed the application forms they were returned to her to forward to HDC.
