3.2 Stearsby and Brandsby to Easingwold road pot holes

Mrs Patmore will again report to NYCC the very bad state of the road between Brandsby and Easingwold. She stated that NYCC has been awarded more money for repairing the roads and hopefully this will be done in due course. Mr Pearson Adams has done some work on the pot holes in Stearsby but said it would probably be an ongoing problem.

The clerk was asked to write to Morisons about the hole in the road on the left when turning out of The Avenue.

3.3 Traffic calming measures

Mrs Patmore said it was a waste of time asking for speed calming through the village as there were no funds available for permanent traffic calming at present.

3.4 Hedge and verge cutting in the village

This had been done satisfactorily by Mr Craggs.

3.5 Playground update

6. CORRESPONDENCE

1. A letter has been received from Graham Kay, Chairman of the Cholmeley Hall committee advising the councillors of the following: -
 - The hall is underused by the residents and little interest is shown by outside bodies
 - The running of the hall – the social events take a lot of organising and attendance is mixed and the cleaning, buying supplies etc tends to fall on only a few.
 - The condition of the hall – condensation is the principal problem and with so little use large parts of the property is left empty and unheated.
 - The committee members are dwindling and there seems to be no villagers willing to undertake this commitment.

The full contents of this letter were discussed and the Brandsby PC chairman, Mr Pearce is going to have a meeting with Mr Kay to see whether the Parish Council can be of assistance.

It was also suggested a meeting be set up between the Parish Council members and members of the Cholmeley Hall Committee.

2. HDC – Minerals Waste Joint Plan meeting – Issues and options consultation- Mr John Ward has taken this information.
3. HDC – Review of Polling Districts and Polling Places for Parliamentary Elections – Cholmeley Hall listed – nothing to do.
4. HDC – Parish Precept – reply sent by email 30.10.13 for £1,500.
5. Felling of trees at The Old Rectory – Concern that some of these trees may have a TPO on them. HDC replied that their records do not appear to show any trees with a TPO within the grounds.
6. Parish Councillors – The Clerk received a telephone call from Mr Waite of Peel Park asking if there was a vacancy on the Parish Council as he was interested in being a councillor. Although Peel Park farm is outside Brandsby parish boundary Mr Waite would be eligible to stand as he owns land within the parish boundary. The Clerk responded by letter stating that there was not a vacancy at present and that the next parish council elections would be in May 2015.
7. Various correspondence dealt with by the clerk as necessary.

7 ANY OTHER BUSINESS

1. Mr Machin asked whether it would be possible to move the Brandsby village sign and the 30mph sign from near Home Farm to beyond the church. Although Mrs Patmore did not think NYCC would move these signs she would ask the question.

As there was no other business the meeting closed at 8.40pm.
