

**MINUTES OF BRANDSBY-CUM-STEARSBY PARISH COUNCIL MEETING**

**2. MINUTES OF THE LAST PARISH COUNCIL MEETING HELD ON 5 OCT 2017**

The Minutes having been circulated to the councillors prior to the meeting were approved and signed by the Chairman as a true record.

**3. MATTERS ARISING FROM THE MINUTES**

**3.1 Defibrillator for the village**

This has now been installed and is ready for use. The Clerk was asked to contact Easingwold Lions to arrange for a demonstration on how to use the defibrillator and education in the use of CPR. A notice would be put in the church magazine and web site advising on where the defibrillator is located.

**3.2 Masonry bees in Cholmeley Hall**

No amount was decided for the contribution to the Cholmeley Hall account for the restoration to the damage caused by masonry bees.

It was decided that work on the hall was needed as soon as possible. The two members of the public are members of the Cholmeley Hall committee. They did not wish to take on the applying for grants, fund raising etc so it was agreed that the Parish Council would take on this responsibility in partnership with the Cholmeley Hall Committee.

Personal letters would be sent out to each householder setting out the problems and asking if they would be willing to give financial help. Estimates for this work would be needed. The Clerk would begin the necessary formalities.

**3.3 Road repairs Brandsby to Crayke road**

Although not perfect the road has been repaired. But there is a problem with water spilling onto the road at Far Rush, and the road near this point is breaking away. The Clerk will inform NYCC.

**3.4 Culvert in Stearsby**

The culvert has collapsed. Mr Pearson Adams will deal with this.

### **6.5 Traffic concerns – Mrs Ruck Keene**

Mrs Ruck Keene is concerned about the speed of cars through the village and whether anything could be done about it. The clerk replied that over the years the councillors have been aware of the problem. Due to HDC cash restraints nothing will be done until it is proved necessary. There has been a police presence checking cars on many occasions during the past months.
