8.2 Villagers in Stearsby are not satisfied with the state of the road in the village. Mr Pearson Adams has spoken to the persons concerned.

8.3 The junction of Yearsley road in Brandsby village

The Clerk was asked to write letters to the owners of the vehicles parking, in the village, on the road /path near the Yearsley junction, requesting them not to park there as they obstruct the view for any one pulling out of Yearsley junction.

8.4 Cholmeley Hall Committee

Mr Frank Valentine has resigned as Chairman of the Cholmeley Hall Committee, therefore at present there is no Chairman.

Mr Eglinton reported that two projects need to be done in the Hall – Combat damp and the removal of masonry bees. A quote for these projects is to be presented to the PC at the next meeting. The councillors will then decide on an amount for a donation towards these projects.

8.5 Steps leading from the main road to Cholmeley Hall

The Clerk was asked to contact NY Footpaths department or the department for the Area of Outstanding Natural Beauty to ask them to repair these steps and the handrail.
