**1. APOLOGIES FOR ABSENCE**

**2. MINUTES OF THE LAST PARISH COUNCIL MEETING HELD ON 17<sup>th</sup>  
MAY 2011**

The Minutes of the meeting were circulated prior to the meeting. These were approved and signed by the Chairman.

**3. MATTERS ARISING FROM THE MINUTES**

3.1 Planning Application – Bycrofts “Holiday home”. Several emails have been sent to HDC regarding the present position. No replies have been received. The Clerk was asked to keep sending emails for an update.

3.2 Playground update

Mrs Teresa Jones, one of the members of public present, reported that the playground was progressing slowly. There were problems with laying the ground surface as some of the equipment has already been installed making the surface difficult to lay.

3.3 The Granary

HDC have closed the case and Mr Pearson-Adams, a near neighbour, is happy with the outcome.

3.4 Damage to the railings, by HDC, at West Lodge

This is ongoing.

3.5 Water running off hillside onto Yearsley Road.

NYCC, Highways, Thirsk, have looked into the problem and checked the gullies which, they found, were working correctly. Some grips need introducing along the road to assist drainage. This will be done when funds are available.

Mrs Patmore will follow this up.

3.6 Lay-by in Brandsby village

The lay-by has been retarmaced. There was concern that cars park in this lay-by on a morning when waiting for the school bus. It would be more sensible for the bus to be able to park there rather than the cars. The Chairman will ask the car owners concerned if they would kindly consider parking elsewhere.

3.7 Sewage Agreement

A cheque was signed for Mr Alan Grainger for the £1,000 payment. The Clerk will deliver this cheque to him.

4. PLANNING APPLICATIONS

- a PROPOSAL: Demolition of existing agricultural building, alterations and extensions to existing dwelling and alterations to agricultural buildings to form ancillary accommodation.

LOCATION: Stearsby Hagg Farm, Bonnygate Lane, Stearsby

APPLICANT: Mr G Page.

- b PROPOSAL: Application to replace extant permission in order to extend the time limit for implementation of alterations and extensions to existing agricultural buildings to form 3 holiday units.

LOCATION: Mill Farm, Crayke Road, Brandsby

c. SEAVES FARM

There was concern from the neighbouring properties, (although nothing in writing to BPC) regarding HDC planning restrictions. One of HDCs conditions of approval was – no retail sales from site.

Mr & Mrs Kitson the owners, and members of the public present, confirmed that they have been in contact with HDC and, they said, no planning regulations have been contravened. There was concern from Mrs Patmore regarding the access. Mr Kitson said that this was a small enterprise and very little traffic was anticipated. Mrs Cookson agreed to contact HDC and Mrs Patmore said she would contact NYCC Highways for their comment

As Brandsby PC have not been informed (regarding the selling aspect) on this application the issue is between HDC, NYCC and the neighbours.

d. WOODMANS COTTAGE

Mr Moubrey has written to HDC regarding the trees owned by him and his neighbour. An application for work on these trees will be received in due course. The main concern, in the tree inspector's opinion, were the trees belonging to Mill Hill. High winds could bring down trees onto Mr Moubrey's property. In the inspectors opinion at least one of the trees is very dangerous and should be felled. Mr Mowbray was asking NYCC/HDC to come and take a look.

5. FINANCE

The balance of the current account as at 21<sup>st</sup> September 2011 is £3,140.78.

Arrangements will be made to close the Millenium Fund account, transfer the balance to BPC current account and pay the closing balance to the Brandsby Playground Account.

7.2 **Re Sewage Agreement – Hileys invoice** – An invoice to BPC for approximately £500 has been received from Hileys for this work. The quote from Hileys for this work was for approximately £175 plus VAT. Roger will speak with Giles Scott of Langleys Solicitors re this invoice.

7.3 **Renting of field -** Mr Johnson will not be renting the field from April 2012. This will be put out for tender in Feb/Mar 2012. The Clerk was asked attend to the appropriate notice.

7.4 **Fly tipping** on Stillington Road near the concrete block. The Councillors were asked to report any incidents.
