2. MINUTES OF THE LAST PARISH COUNCIL MEETING HELD ON 3 NOVEMBER 2020

The Minutes having been circulated to the councillors prior to the meeting were approved and signed by the Chairman as a true record.

3. MATTERS ARISING FROM THE MINUTES

3.1 Overhead branches near Cranmore – these have now been removed

3.2 Speeding through Brandsby – Following the correspondence from Mr McGovern the clerk sent a letter to NYCC outlining the problem. We have had no response.

Various emails have been forwarded to the clerk from NYCC, NY police, Mrs Patmore (NYCC rep) and Mrs Watkins (HDC rep) and residents of Brandsby regarding the speeding issue. These concerns will be discussed at length at the next meeting and include a request to extend the 30mph speed limit sign to beyond the church.

Before this meeting the clerk contacted the clerk of Crayke PC after seeing that they have installed traffic calming equipment in Crayke. Their reply was very useful and they are happy to advise us in the future if required.

- 6.1 Speeding in the village & 30mph signs – This will be dealt with at the next meeting (see Matters arising)
- 6.2 HDC – New property address – Barn conversion at Seaves Farm. This will be called Mulberry Park, Stillington Road.
- 6.3 Bollards at Stearsby crossroads – Bollards were erected at Stearsby crossroads after a resident of Stearsby complained about parking on this piece of land. After many objections from the villagers and the councillors these have now been removed.
- 6.4 NYCC – There will be a contribution from NYCC of £75.40 towards the cutting of the grass to assist visibility at junctions. We will continue to have this done by our contractor, Ian Craggs.
- 6.5 Welmedical – re defibrillator – Their records show that the defibrillator battery is now out of warranty.

Before purchasing a new battery at a cost of approximately £180 the clerk was asked to contact Welmedical to ask whether they service these machines to ascertain whether or not we need a new battery.

(After the meeting I contacted Welmedical re a service and asked them to check whether we needed a new battery. I was told that the Defib was checked each night remotely and that a new battery was not needed until Feb 2022. A note has been made to order a new one near Christmas 2021)
