24/45 APOLOGIES & DECLARATION OF INTERESTS

24/48 NORTH YORKSHIRE COUNCILLOR'S REPORT

- g. North Yorkshire Highways had checked the tree at the White House and it was not a danger to the highway.

It was again agreed that there was no requirement for Vehicle Activated Speed signs in the village.
